LIABILITY RELEASE & INDEMNIFICATION AGREEMENT - In consideration of Stoney Meadow Farms, LLC (hereinafter referred to as the "STABLE") allowing my participation in any equine activity, whether for compensation or not, under the terms set forth herein, I, the rider and the parent or legal guardian thereof if a minor, do agree to indemnify and hold harmless the STABLE, its owners, agents, employees, officers, premises owners, insurers, and affiliated organizations (hereinafter referred to as "Stable's associates") from any and all liability, loss, damage, claims, and demands, including court costs and attorney fees, resulting from injury of any nature, including personal and property injury, that I, or my minor child, and/or any family member, invitee or guest I bring onto STABLE's premises, may sustain due to any acts or omissions, negligent or otherwise, of the STABLE and/or Stable's associates; and I do further agree that I shall bring no claims, demands, actions and causes of action and/or litigation, against the STABLE and/or Stable's associates for any economic and non-economic losses which arise due to bodily injury, death, and/or property damage sustained by me and/or my minor child or legal ward, any family member, invitee or guest of the same sustained while using these premises and/or participating in activities on or sponsored by the STABLE, even if said injury may result from any acts or omissions, negligent or otherwise, of the STABLE and/or Stable's associates. I certify that I have read the state Equine Activity Warning and I participate in these activities with full knowledge that equine activities are deemed inherently dangerous, and I fully assume those risks on behalf of myself, my minor child(ren), and/or my family members, invitees and/or guests brought onto Stable's property and/or participating in Stable's activities.

WARNING

Under Kansas Law, there is no liability for an injury to or the death of a participant in domestic animal activities resulting from the inherent risks of domestic animal activities, pursuant to K.S.A. 60-4001 through 60-4004. You are assuming the risk of participating in this domestic animal activity.

Inherent risks of domestic animal activities include, but shall not be limited to:

1. The propensity of a domestic animal to behave in ways, i.e., running, bucking, biting, kicking, shying, stumbling, rearing, falling or stepping on, that may result in an injury, harm or death to persons on or around them;
2. the unpredictability of a domestic animal's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals;
3. certain hazards such as surface and subsurface conditions;
4. collisions with other domestic animals or objects; and
5. the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the domestic animal or not acting within such participant's ability.
